**RULES AND GENERAL INFORMATION GENERAL INFORMATION**

1. Sale entries are due 3/7/2025. **Entry forms may be received via email to [vaangus1933@gmail.com](mailto:vaangus1933@gmail.com) or paper mail to Virginia Angus Association 644 Greenville Ave #220 Staunton VA 24401. Regardless of submission method, payment must be received by the deadline.**
2. All consignors shall be in good standings with the American Angus Association.
3. All entries must be registered with the American Angus Association.
4. All cattle sell under the sale terms and conditions of the American Angus Association.
5. Consignor must own all entries at the time of entry.
6. Tattoos will be verified at sale site and must be correct with AAA registration papers. Please check tattoos before entries are made. Tattoos must be legible!
7. All animals (HEIFER, DONORS, PICKS, FLUSHES AND PREGNANCIES LOTS) will have an entry fee of one hundred dollars (\$100) US per lot. It will be put towards sale expenses. It is non-refundable. EMBRYOS AND SEMEN WILL BE \$50 per lot entry fee.

**HEALTH REQUIREMENTS**

All animals entered in sales must meet the following requirements

1. Be officially identified with a “840” RFID button issued by a state or federal animal health program and entered on a Certificate of Veterinary Inspection (CVI) issued by an accredited veterinarian within 30 days of the sale
    - Out of State Cattle: Permit Number Required
    - A. Electronic Certificate of Veterinary Inspection (e CVI) from Global Vet Link
- OR
- B. Paper CVI with permit number. For more information on obtaining a permit number go to [www.vdacs.virginia.gov/animals-cattle.shtml](http://www.vdacs.virginia.gov/animals-cattle.shtml) or contact: Rick Odom 804-692-0600
  2. CVI shall list each animals LOT NUMBER, “840” RFID number, age, sex, breed
  3. All non-virgin breeding bulls under 18 months of age or bulls greater than 18 months of age require a negative Trich test within 30 days of entry.
  4. All animals must be free of infectious and contagious diseases; including: Ringworm, Warts and Pinkeye

5. Meeting the entry requirements for Virginia does not guarantee entry into other states. Animals not meeting the above requirements may be refused admission and may not be sold.
  - a. The above CVI's accompanying each animal shall be delivered to sale management upon arrival to the fairgrounds.
  - b. Make enough copies of each CVI to represent each lot (i.e. 6 lots = 6 CVI copies)**

**These requirements are a complication of the 2020 Beef Expo Committee and Interstate Import Requirements.**

### **CONDUCT OF THIS SPECIAL SALE**

1. Stalling will be assigned in the sale cattle area provided by sale management.
2. Sale cattle must be in place by Wednesday, April 16th at noon.
3. Sale order will be determined by sale management and the Virginia Angus Association.

### **DEADLINES**

1. Pedigree information, entry fees, photos & footnotes must be to sale management by 3/7/2025
2. Please make sure quality pictures and videos are taken. We expect a strong online presence through SaleRing.Live, a quality video will help tremendously for those bidding off-site. This will be a necessity for Donors or other special lots that cannot be at the sale site for extenuating circumstances. If you plan to include photos of your lots please arrange with this deadline in mind.
